## Moving Services Agreement

*(Gentlemen Movers and customer initial)*

### Charges for Moving and/or Packing Service

I understand and agree that the total bill presented to me at the completion of the move is based on the actual number of hours it takes to load, move and unload my possessions, multiplied by \$\_\_\_\_\_ per hour. Per hour, plus supplies is applicable. We charge in ¼ hour increments, five minutes into the next ¼ hour, we round to the next full ¼ hour. We have a minimum charge of two hours. There is an extra charge on certain oversize or unique items which includes: pianos, organs, safes, large screen TV's, full size copiers and fire-proof file cabinets, etc. Any estimate given by Gentlemen Movers for this move, prior to signing this agreement, has been made as carefully as possible, based on the information provided to us. The estimate was based on your place of residence or business being packed and ready to move.

### Payment

Payment is due at the completion of the move. Payment can be made by cash or check (payable to Gentlemen Movers). In the event of non-payment, Customer agrees to pay interest at the rate of 1.5% per month on any past due balance.

Customer agrees to pay expenses incurred by Gentlemen Movers in seeking payment, including but not limited to reasonable attorney's fees. The highest handling charge allowed by law is issued to checks returned due to non-sufficient funds.

### Damage Claims

Although our movers will be careful with your possessions, from time to time damages may occur. If damage is caused by our service, Gentlemen Movers reserves the right to repair the damage(s) in question. If we determine that a damage cannot be repaired, we reserve the right to either replace or compensate (actual cash value of the day the it is being moved) for the damage. If there is damage, notify your movers immediately. They will complete a Damage Report before they leave your site. If you discover damage after the move, call the office within 96 hours of your move. No damage claims will be honored until the charges for moving services are paid in full. Damages caused while unloading/loading your truck or storage unit: Gentlemen Movers is only responsible for items in our immediate care, custody and control. Gentlemen Movers in not responsible for the disconnect or reconnect of water or electrical items, such as Washers and dryers. You will be asked to sign a Release of Liability acknowledging this. Gentlemen Movers is not responsible for items broken by customer on the job. Gentlemen Movers are not responsible for damaged item that customer packed themselves, particle board furniture, stainless steel, fine artwork, fine China or lost jewelry.

Gentlemen Movers when loading a pod or someone else's truck is not responsible for any damages that may occur during transport.
